# **98C Additional Funding**

To be eligible for funding in section 98c, LEAs (Local Education Agency) must apply to MDE no later than November 30, 2022. Eligible entities must include the following in their application:

- An assurance that by not later than October 30, 2022, at a public meeting of the board of an LEA, a presentation is provided on how funding received under section 98c will be used to address learning loss.
- A link to the plan to address learning loss that is posted on the LEA's website and an assurance to post updates to the plan on the LEA's website.
- A brief description of the district metrics to be used to determine the impact of the district's funded initiatives.





# **98C Additional Funding**

- Section 98c funding will be distributed to each LEA in an equal amount by per pupil in membership.
- Eastpointe non certified count for Fall 2022
  - Preliminary count 2243 students
  - Estimated funding will be determined based on fall count and sent to LEA by November 30, 2022
- Expenditure period ending September 30, 2023

### **Administering and using High Quality** Assessments

- NWEA (3 times per year)
- Formative Assessments
- Targeted checks
- Determining students social, emotional and physical well being assessments
- Digging Deeper Assessments in Literacy





### **Implementing Evidence-Based Activities**

- ECS has prioritized standards and identified essential skills in scope and sequence of materials.
- Weekly teacher release for Professional Learning Communities \_\_\_\_ practices
  - What are students expected to learn?
  - How will they know if they learned it? —
  - What will be the response if they do not learn it?
  - What will be the response if they already know it?
- FOCUS on high quality grade level content at Tier 1 Instruction
- High dosage tutoring for identified students ----
  - Pilot in 2021 high impact for students served





### **Providing Information and Assistance to Parents and Families**

- District Goal of Climate and Culture is infused with Parent Involvement
- Funding a Parent Advocate
- Increased focus on communication with parents and families
  - Using Parent and Family Events
  - Parent University
  - Improved Communication with Families

### **Tracking Student Attendance and Improving Student Engagement** (for students in remote learning only)

- ECS found an area of need in consistent MTSS processes across the district
  - Implementation of MTSS Coordinator Position
  - Better support for Building Level MTSS processes
  - Improve the SYSTEMS for identifying students in need
- Hybrid Instruction 6-12
  - Increase in relationship building with smaller groups on in person students
  - Absences from face to face school don't disrupt learning
  - Training for Coaches and Leaders in Engagement Strategies
    - Dr. Pam Rosa
    - Instructional Coaches
    - Partnership with MSU
    - professional development




### **Monitor Student Academic Progress to Identify Students Who Need More Help**
