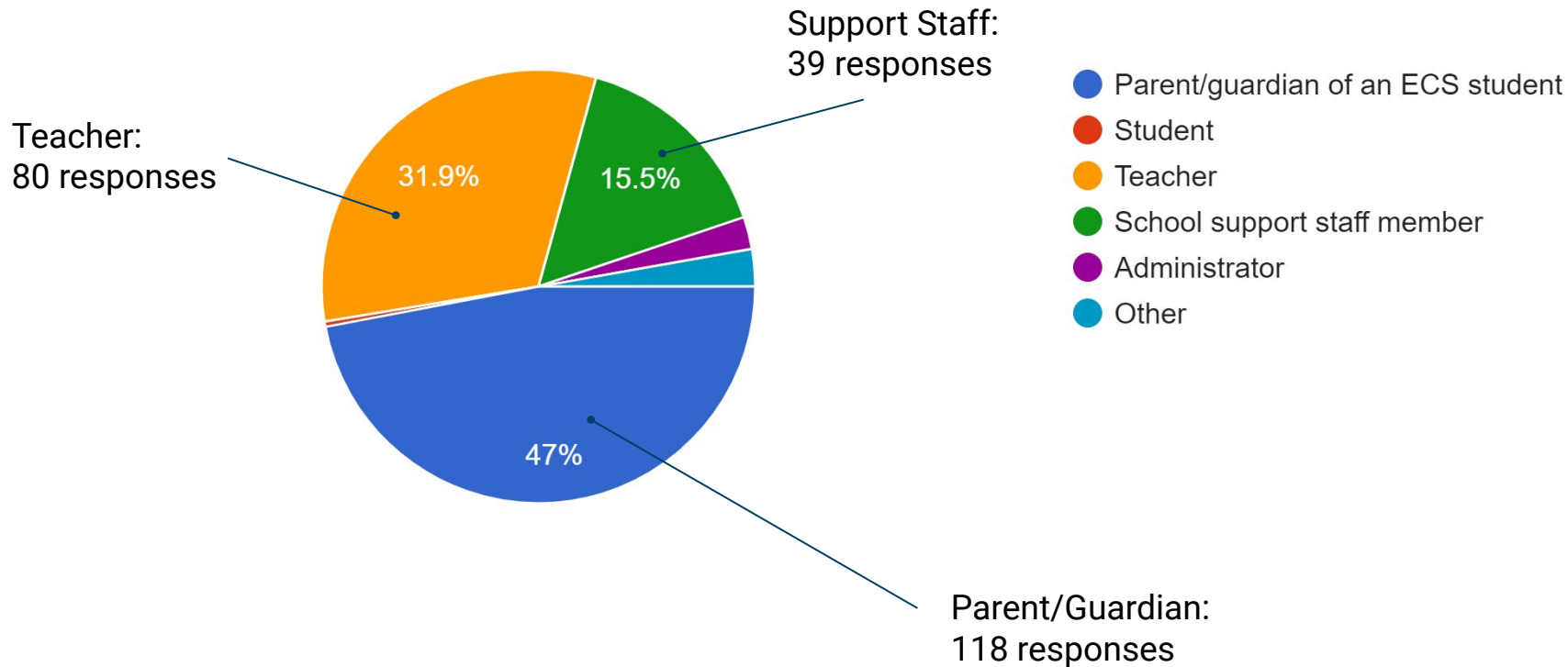

ESSER III Stakeholder Survey

- A survey was sent via SchoolMessenger (our district robocall and email system), as well as through district staff listservs, to all parents/guardians and staff on December 3, 2021. A reminder call was also sent asking parents to check their email and complete the survey.
- Respondents were asked to identify their stakeholder group and the building or buildings that they are currently affiliated with, and then asked to rate several possible uses of ESSER III funds. They were also given an open text box to make additional suggestions for use of the grant funds.
- A total of 251 responses were received over the course of the survey.

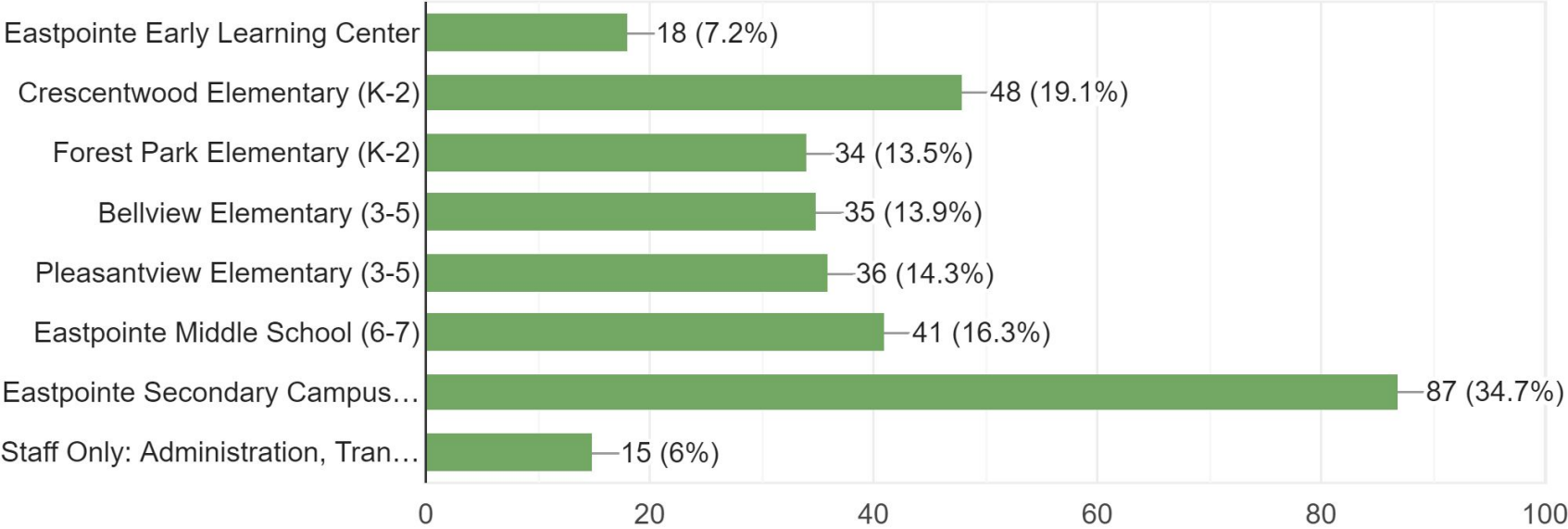
Which stakeholder group best describes you?

Potential Uses of Grant Funds

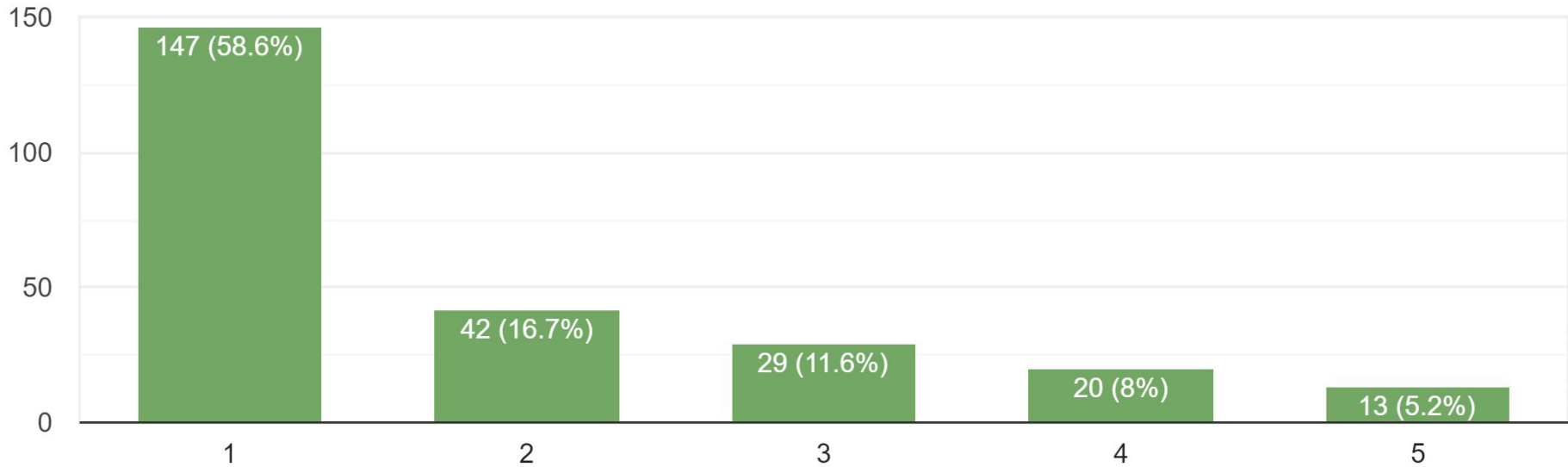

- Provide social-emotional support such as counseling and mental health and wellness resources for students, staff, and families.

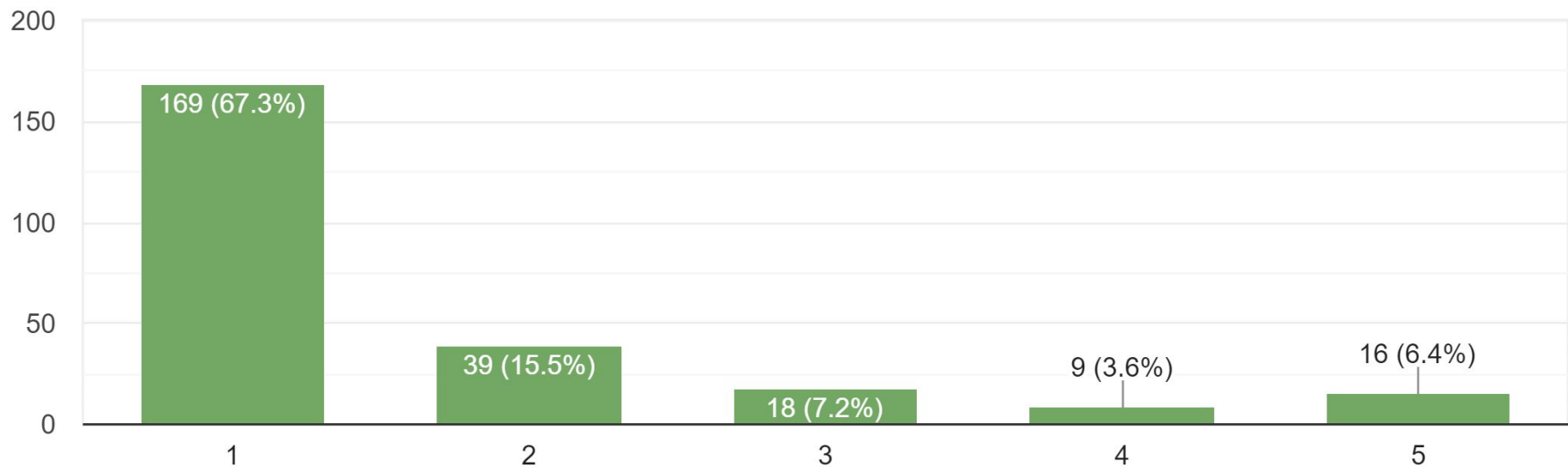

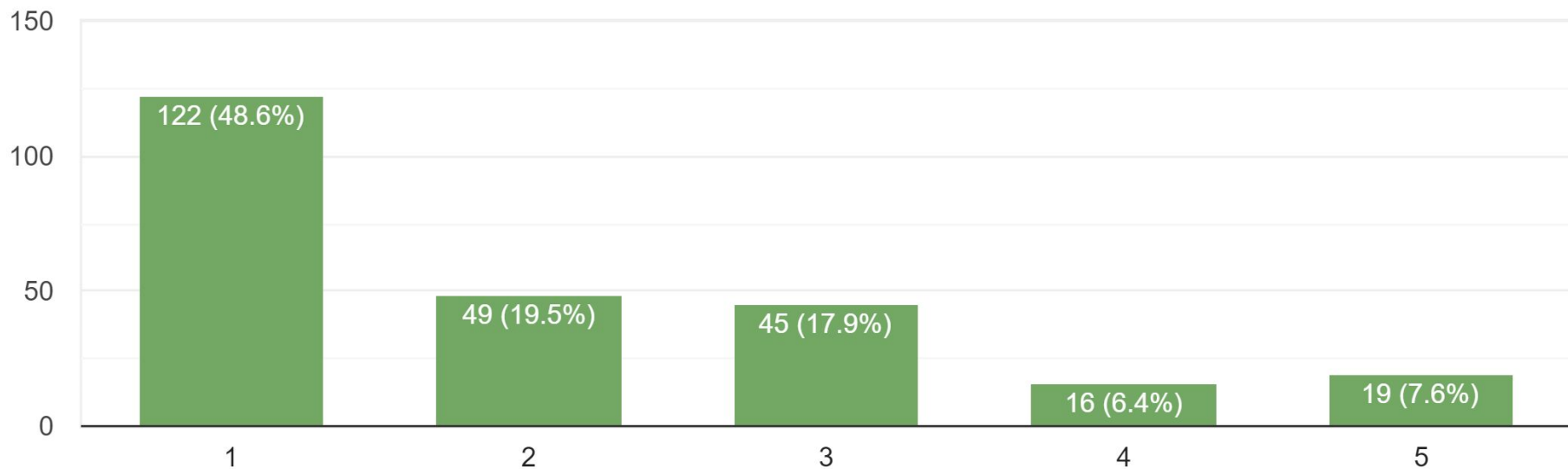

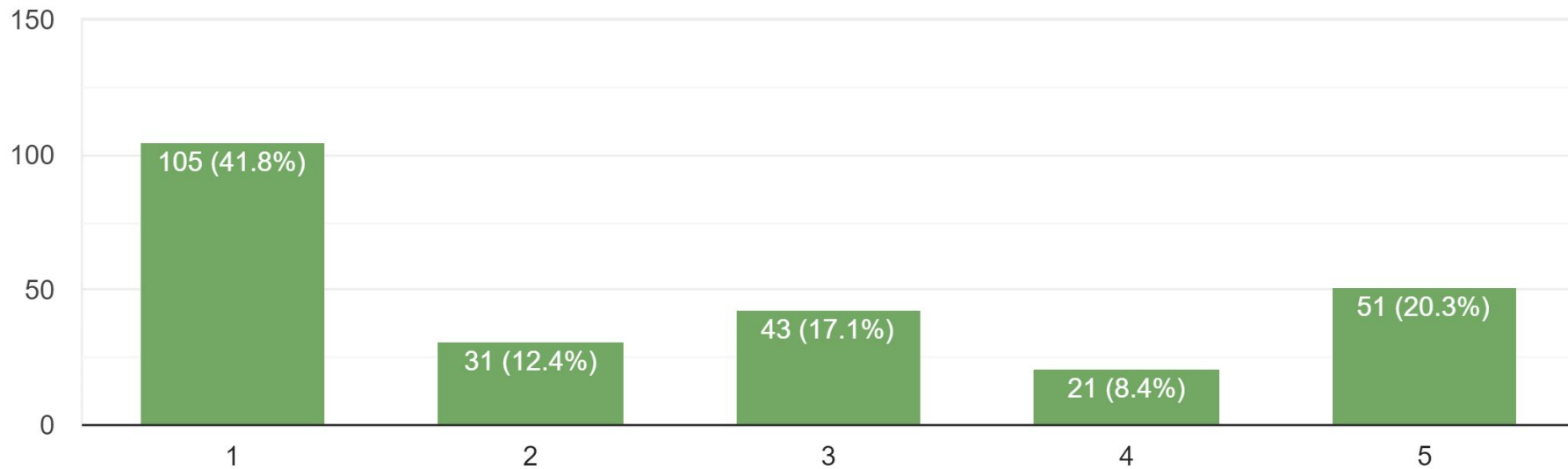

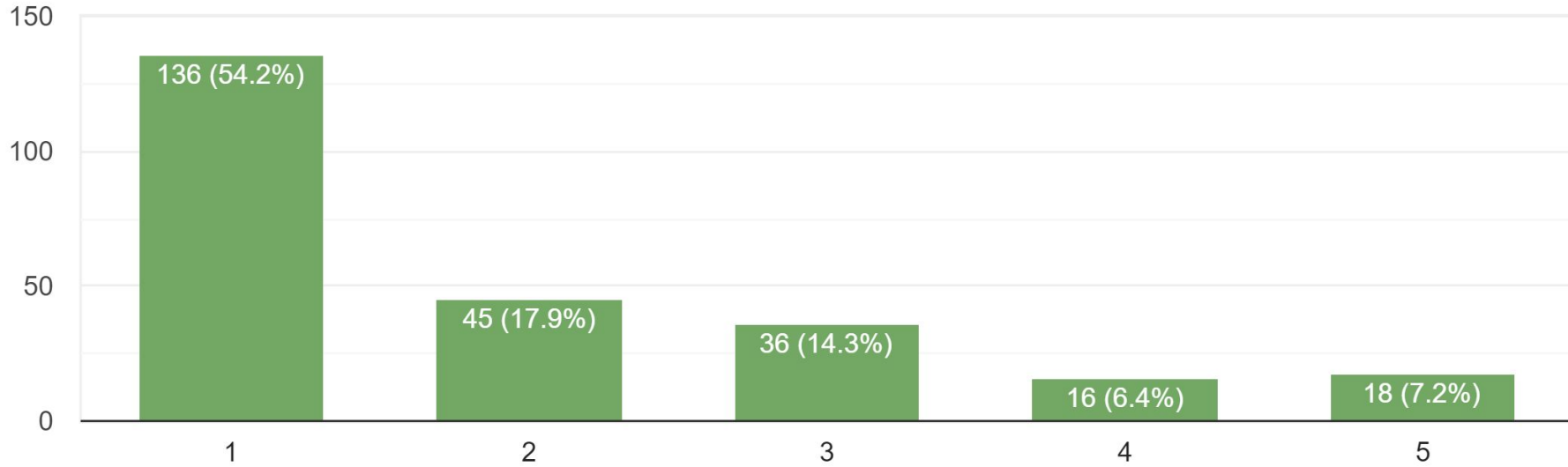

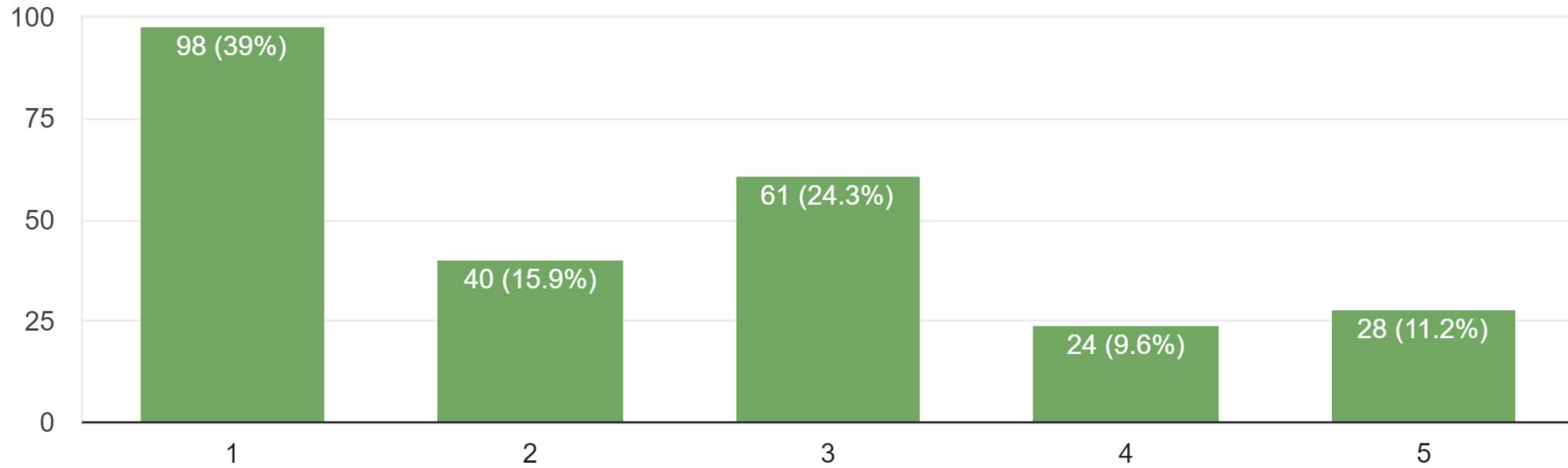

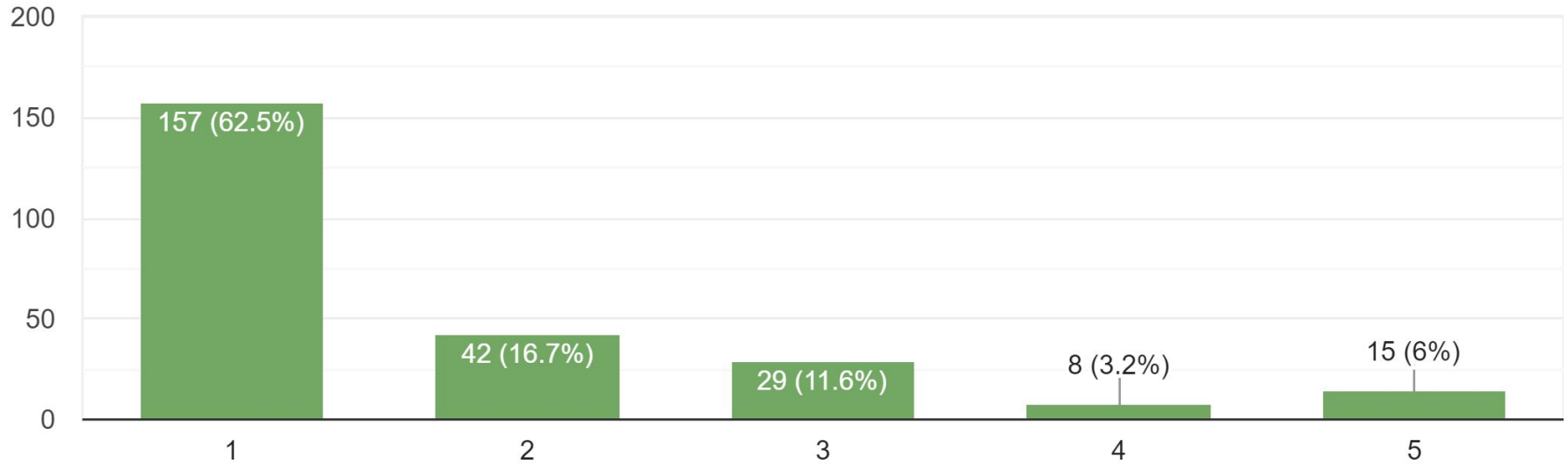

Stakeholder Priorities Ranked

Based on the average ratings of all survey responses, the priorities of stakeholders are ranked as follows:

1. Improving indoor air quality/comfort (avg. 1.688)
2. Providing social-emotional support (avg. 1.739)
3. Repairing and improving facilities (avg. 1.859)
4. Instructional materials to help with learning recovery (avg. 1.933)
5. Purchasing educational technology (avg. 2.046)
6. Summer learning opportunities (avg. 2.365)
7. Free preschool programs for 3 & 4 year olds (avg. 2.539)
