For students entering grades K – 5

1. Applications are being accepted for students in grades K-2 at Crescentwood and Forest Park, and grades 3-5 at Bellview and Pleasantview through September 8, 2023.
2. The buildings available for In-district Schools of Choice students and the number of spaces in each building will be determined by Eastpointe Community Schools.
3. Eastpointe Community School's registration process for students accepted through In-district Schools of Choice must be completed by September 8, 2023. If students are not registered by that date, Eastpointe Community Schools will assume that the application for Schools of Choice has been withdrawn.

Attendance

Transportation is not provided for Schools of Choice students. Students are expected to arrive and depart school on time, in accordance with the Eastpointe Community Schools' Attendance Policy and Student Code of Conduct. It is expected that parents will pick up students on time when they are attending an after school or evening event.
