Agenda Items:

1. Public comments from parents and/or guardians

Reconfirmation must occur at a meeting of the school district's board or board of directors, and the school district must solicit public comment from the parents or legal guardians of students enrolled in the district during the reconfirmation meeting.

2. Review weekly 2-way interaction rates

The school district must publicly announce its weekly 2-way interaction rates at each reconfirmation meeting.

3. Reconfirm how instruction is going to be delivered during the 2020-2021 school year

30 days after the school district's Extended COVID-19 Learning Plan has been approved and every month thereafter, the school district must reconfirm the manner in which instruction is going to be delivered during the 2020-2021 school year.




